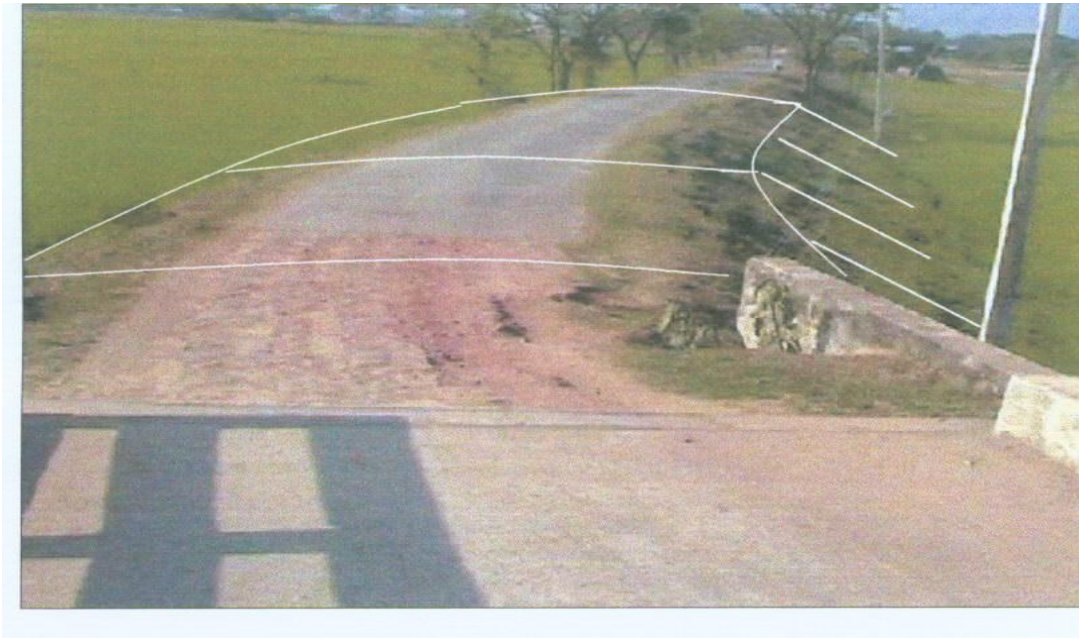

**SOCIAL SCREENING REPORT
(For First Year Sub-Projects)**

1. BACKGROUND

The Local Government Engineering Department (LGED) under the Ministry of Local Government, Rural Development and Cooperatives (MoLGRD&C) is going to undertake Second Rural Transport Improvement Project (RTIP-II) with a view to construct and maintain rural transport and trade infrastructure. As a part of project preparation LGED has adopted Social Impact Management Framework (SIMF) following WB's Operational Policy (OP 4.12) and the Acquisition Ordinance of the GoB (1982). The SIMF contains detailed guidelines and Principles for mitigating losses of different types of property (land and non-land) that might have been caused by the programme of land acquisition. The report will show the screening results of first year sub-projects under RTIP-II.

2. OBJECTIVES

The primary objective of this social screening is to identify potential safeguards compliance issues and social impacts associated with the rehabilitation and improvement works, in order to determine applicability of the OP 4.12 and OP 4.10 and the required Social Management Plans.

3. METHODOLOGY

The screening is based on a collection of primary data and information duly conducting filed survey for each and every first year sub-projects. A structured questionnaire was administered for obtaining necessary primary data relating to land acquisition requirements, land ownership, losses of land and other assets etc. Further information was obtained through field visits, interviews of relevant key informants and most importantly Focus Group Discussion (FGD) and Participatory Rural Appraisal (PRA) to capture collective opinions and wisdom. The data was analyzed later using Excel software.

4. KEY FINDINGS

4.1 LAND REQUIREMENTS

It revealed that no alignment of the selected all sub-projects need any widening or / and rising of the height of the road. This means that all roads are existing and have acceptable geometric dimensions. Therefore, they do not require additional lands to carry out the intended works.

4.2 HOMESTEAD OR/AND OTHER NON-LAND ASSETS

It is noticed that no land belongs to Private Citizens LGED and/or other Government agencies or, has lease agreements with any government agencies will be required. Screening results demonstrated that no private homesteads or business premises/buildings are expected to be affected. The Residential households on LGED's own land & public land will not be affected entirely or partially. Similarly the business premises on LGED's own & other public lands will not be affected entirely or partially.

4.3 INCOME LOSS/ BUSINESS LOSS

It has been observed that no businesses/trading activities that would be displaced from make-shift structures on the road, and other areas/spots. The proposed subprojects works are not expected to affect any community groups' access to any resources that are used for livelihood purposes. None of the community facilities like school, cemetery, mosque, temple, or others religious, cultural and historical properties are going to be affected.

4.4 INDIGENOUS PEOPLE

Although none of the IP is expected to be affected by the project's work, the survey team consulted a number of IP community members and organizations. They have been informed about the proposed interventions and their feedback and inputs have also been noted. Finally the survey team has reached broad-based community consensus on the proposed works which could be seen under:

- IPs will be given preferences to engage them as labors during execution of civil works.
- Local IPs organizations need to be involved in the participatory process where applicable.
- They will be involved in the tree plantation and caretaking program where possible.

5. TEAM COMPOSITION

The Social Screening was conducted by the Socio-Economic Monitoring and Evaluation (SEME) Expert of the Project Preparation Consultants. He was assisted of Community Organizers at the field level. The district level coordination was done by the Senior Assistant Engineer. Data entering, editing, cleansing, validating and analysis were done at LGED HQ by the Socio-Economic Monitoring and Evaluation expert.

6. CONCLUSIONS AND RECOMMENDATIONS

As no land will be required and no private/public/community/cultural property are going to be affected, the proposed first year interventions is not expected to pose significant negative social impact. The ease transportation system may have positive impact on employment, agricultural development, creation of better business environment, promoting education by increasing attendances and felling the rate of drop out. All these factors have incremental value on socio-economic aspects in general and social aspects in particular. Therefore, implementations of the proposed roads are highly recommended.
