THIS AGREEMENT, is made on the 1st day of October 2018 between the Local Government Engineering Department represented by the Executive Engineer, LGED, Narsingdi District hereinafter called "the Procuring Entity" of the one part and M/S DURJOY ENTERPRISE. WHEREAS the Procuring Entity invited Tenders for certain Works, viz. Improvement of Belabo Takpara Mondir Repair, Union: Belabo, Latitude: 24.156, Longitude: 90.552 under Belabo Upazila, Dist: Narsingdi, Tender ID No: 218766, Package No: GSIDP/NSD/DW-66 and has accepted a Tender by the Contractor for the execution of those works in sum of Taka 3,34,400.000 (Taka Three Lac Thirty Four Thousand and Four Hundred Point Zero Zero Zero) only (hereinafter called "the Contract price").
