# 1. Background of the project:

The Local Government Engineering department (LGED) under the ministry of Local Government, Rural Development and Cooperatives (MoLGRD&C) is going to implement Emergency Multi-Sector Rohingya Crisis Response Project (EMCRP) with a view to strengthen the Government of Bangladesh systems to improve access to basic services. The main aims of the sub-project is to strengthen the structural capacity of LGED District level office for ensuring smooth execution of Emergency Multi-sector Rohingya Crisis Response Project as well as facilitate other implementing project within the Cox's Bazar District.

#### 2. Location of Sub-Projects and Targets

The Location of Sub-project situated in the heart of City Cox's Bazar. The World longest Sea beach is very close to the proposed sub-project (Field office Executive Engineer, Cox's Bazar). The sub-project is situated at the north of UNICEF field office and RRRC office, east by LGED staff quarter and some residence, south by private residential area and west by Hotel Saibal. #### 3. Objective of Social Screening:

The main objective of social screening is to identify potential social risks, its significance, and the level of assessment and management required to address them. The objective of screening of this subproject is to identify potential safeguards compliance issues and social impacts associated with the rehabilitation and improvement works, in order to determine applicability of the World Bank policy such as; OP 4.12, 4.10,4.11 and Bank procedures as well as the Law, rules & regulations of The Government of Bangladesh.

#### 4. Methodology:

A two member's team consisting of Social Development Specialist and Field level Environmental Specialist visited the sub-projects and conducted FGD with relevant stakeholders and informal interaction with local community. A structured questionnaire were applied to obtain necessary primary data relating to population, Household, Land acquisition requirement, Land ownership, losses of land and others assets etc.

#### 5. Summary of Key Findings:

Based on filled-up Social Screening form from the field, public and stakeholders consultations the following key findings are summarized;

# 5.1 Scope of Work:

It has revealed that the proposed sub-project is implementing on existing LGED offices premises which ownership exclusively for Government. Moreover, it has found that existing land is enough to extension with renovate the Field office of Executive Engineer, LGED in Cox's Bazar.

# 5.2 Sub Project Impact:

This sub-project will not cause any negative impacts on land, structures, trees, community properties and any other assets. No squatters, vulnerable HHs or any tribal people will be affected.

#### 5.2.1 Land Requirement:

It has revealed that the proposed sub-project will implement on government land within the existing XEN office premises. Moreover, it has found that existing government land is enough to construct the sub project. Even no voluntary land also be required to implement the extension with renovate work. Therefore, this sub-project will not cause any negative impacts.

# 5.2.2 Impact on Structure:

Any structures like homestead, mosque, temple, historical and cultural establishments, business premises, or private infrastructure will not affect partially or entirely for the sub-project implementation. Therefore, population displacement will not be required for implementation of the sub project.

#### **5.2.3** Effect of Squatters:

The proposed sub-project is implementing on existing LGED office premises which ownership exclusively for Government. Therefore, informal settlers and squatters are not living within the premises.

# 5.2.4 Impact on Trees:

No trees will be affected for implementation of this sub-project.

#### 5.2.5 Tribal People:

It has assessed through holding FGD that, no Tribal people (TP) in the catchment areas have found.

#### **5.2.6** Construction Yard:

We have conducted necessary consultation with stakeholders regarding construction yard. It is confirm that the contractor will be used LGED land as a construction yard during construction.

#### 6. Consultation:

Consultation is a process to interact with relevant stakeholders to inform about the sub-project. Involvement of people's with process will create the feelings of ownership within stakeholders that will supports for smooth execution of the project.

Social safeguard team of EMCRP has conducted stakeholder consultation meeting at Upazila officer's club auditorium with an active participation of Upazila level Government officials, local Government, local people, and civil society's representative. Twenty (20) participants were attended the consultation meeting and provided their valuable opinions/suggestions/feedbacks regarding the subproject implementation. The key outputs of stakeholder consultation meeting are;

- Effective coordination will require between the stakeholder's and Government about relief distribution.
- Ensure First-Aid Boxes at the proposed sub-project site
- To arrange training for concern stakeholders about social safety & security, traffic management, labor influx etc.
- Labors must maintain code of conducts to avoid any negative impacts on the neighborhood communities.
- Ensure people participation, which will enhance their sense of belonging of the proposed sub-projects.
- To identify unavoidable adverse impacts and ensure effective mitigation
- To ensure social conflicts and grievance management during construction and operational period;
- Should follow labor law strictly; (code of conduct for labor, Wages, avoid discrimination between male and female workers etc.)
- Child labors must not be engaged during construction
- To ensure equal wage for female labour.

# 7. Contractor and Labor Management:

Except little percentage of skilled workforces, most of the workforces will be engaged from local community except technical workforce and they belong to same socio-economic, cultural, religious or demographic background. Based on consultation with local stakeholders, implementing contractors need to be hired skilled workforce from outside the project area. Therefore, due to small outsider possibility of clash in between local and outsider will not occur. Based on public consultation it also has revealed that, Women's participation in construction work is very limited, and GBV training at the work sites will ensure before construction.

# 8. Traffic Management:

In front the proposed construction site, a wide paved road crosses and to connect with other connectivity. During construction work, traffic movement will not hamper due to sufficient corridor. Construction contractor will ensure traffic management providing a traffic man using traffic sing during construction work.

# 9. Monitoring System:

The LGED overall responsibility for the project implementation, through the Project Management Unit (PMU involving the Upazila Engineer, XEN, D&S Consultants and PMU safeguard team for collection, analysis and reporting. In addition, field level team also responsible to collect update information as well as any adverse impact during the construction. These stakeholders will be responsible for monitoring the progress of all aspects considering any significant impacts are raised and to suggest action to be taken against any adverse impact. The construction contractor will be deployed a Social safeguard Officer to monitor the field level safe guard activities and will be reported to the concern persons. Field level data will collect on regular basis to check the progress whether sub project activities on track or not.

The major objectives of monitoring are to:

- (i) ascertain whether activities are progressing as per schedule and the specified timelines are being met;
- (ii) assess if compensation, rehabilitation measures are sufficient; (iii) identify problems or potential issues if available/necessary; and
- (iii) (iv) identify methods to rapidly mitigate any problems.

The above information's will be collected by LGED through its PMU and respective Upazila Engineer and D&S Consultants. They are responsible for monitoring the day-to-day resettlement activities of the subproject.

#### 10. Grievance Redress:

EMCRP have formally formed GRCs consisting of 07 members with the Upazila Engineer of the concerned Upazila. A Grievance Register also maintaining at each Upazila and Executive Engineers Office office.

Community members are encouraged to present any complaints to Upazila level GRC and women's are encourage to complaints at her convenient place, which are notice at GRC for resolve. In addition, PMU using contact details displayed on the Environmental and Social signboard and detail stated in GRC leaflet, which will disclose within project area very soon.

#### 11. Social Management Plan (SMP):

Based on public consultation a Social Management Plan identifies the mitigation and management activities that need to be in place in order to eliminate the marginal social impacts or to reduce them to an acceptable level and the process will continue subsequently.

#### 12. Recommendations:

Disclosure of all relevant project construction work, information dissemination and continuous consultation processes with the concerned communities are recognized as extremely important. In

particular, involvement of relevant stakeholders in the sub-project implementation process will help to build a sense of ownership within community. Further, establishing and maintaining an effective Grievance Redress Mechanism (GRM) would enable any affected parties to present their issues and equitable solutions of their problems by impartial hearing.

Most importantly, issues are social safety, during the construction period. Before starting construction work, the people to be engaged for construction of shelters should undergo a short orientation course

#### 13. Conclusions:

Implementation of Extension with renovation under the package of EMCRP/W-7 will implement in government land within EEs office premises. The existing land is sufficient for proposed sub project. A Management Plan has prepared for mitigation of problems if arise during construction work. The proposed sub-project intervention will not pose any significant negative social impact. Therefore, implementation of the proposed sub-project is safe and highly recommended.
