A Pre-Proposal Meeting of the short-listed NGOs of package RERMP-3/S-2/Z-09 and package RERMP-3/S-2/Z-10 under Capacity Development of Selected Destitute Women Crews under Rural Employment and Road Maintenance Programme-3 (RERMP-3) chaired by Salma Shahid, Project Director, RERMP-3 was held on 14/03/2022 at 12.00 PM in the office of the Project Director, RERMP-3 (level-10) of LGED. The list of participants who attended the meeting is attached in Annexure-1.

At the outset of the conference, the Chairperson welcomed all the participants and said that the main objective of the conference was to clarify different points on proposal preparation. She added that the ITC clause no 54.1 will be replaced by "The amount of performance Security shall be 3% (Three percent) of the Contract Price." She also mentioned the following amendments -

- In Proposal Data Sheet ITC clause no 21.1 (c), <u>"submission of Assignment Completion</u> <u>Certificate is not compulsory"</u>
- In TOR article-8.2Position: Training Supervisor, "maximum age limit for the Training Supervisor is 50 (fifty) years"
- In Form 5A1 (page no-52), Para no-4, ITC Sub Clause 56.1 will be replaced by <u>"ITC Sub Clause 58.1"</u>

Then she invited all the participants to express their views on the terms and conditions of the Proposal Document or any other query. After that the floor was opened for general discussion:

- All legal documents including NGO Bureau Certificate, TIN Certificate, VAT Certificate have to be provided (for both lead and partner NGO)
- Form 5A2 Consultant's Organization and Experience has to be filled carefully
- Approach methodology, work plan, work schedule, starting schedule, organization & staffing schedule, CV formats have to be prepared carefully
