Quality Assurance Plan (QAP)

The Bidder shall submit a QAP outlining the following with reference to the Specifications document and the Item Description in the BOQ:

- Proposed quality management arrangement including quality assurance staff and their responsibilities;
- Envisaged sources of material and their route of transport;
- Quality control tests on material and product; and
- Facilities available at the Contractor’s material laboratory at site and location of other laboratories for the tests which could not be conducted at the Contractor’s site laboratory.
