Assignment Title: Communication and Awareness Consultancy Services for Emergency Multi-Sector Rohingya Crisis Response Project (EMCRP)

The Peoples' Republic of Bangladesh has received financing from the World Bank toward the cost of the Emergency Multi-Sector Rohingya Crisis Response Project (EMCRP), and intends to apply part of the proceeds for consulting services. The consulting services ("the Services") include: (i) complement and strengthen the implementing agency (LGED and DPHE) capacity to undertake behavioural change communications to create broad-based public support for the proposed project, (ii) develop and implement a robust communication strategy using multiple and suitable communication channels to generate awareness and motivate the displaced Rohingya populations to engaged in activities to benefit from the project interventions with consultation with the implementing agency, (iii) facilitate two-way communication, engagement and consultations with key stakeholders, including the refugees, host communities, religious leaders, civil society, and other government & non-government agencies, (iv) inform the affected communities, including the host community regarding the necessity and the benefits of project interventions with a focus on maintaining social cohesion, (v) address potential resistance and mitigate any evolving risk of opposition, (vi) create broad-based consensus for the project interventions, (vii) communicate project results at local and national level.

Tentative duration of the assignment is 30 months and expected to commence in July 2019.

The detailed Terms of Reference (TOR) for the assignment is available in the office of the under signed.

The Local Government Engineering Department (LGED) now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- Back ground of the firm with brochure showing core activities;
- Registration /incorporation of consultants (with supporting documents);
- Experience in similar assignments (with assignment & project name, client, funding agency, consultancy cost and duration during last 10 years preferably in Project Data Sheet);
- Availability of professionals with appropriate skills (No CV for individual experts);
- Resources (Turnover) and
- Audited financial reports of last three years.

Key Experts will not be evaluated at the shortlisting stage.
