The Local Government Engineering Department has been allocated public fund from the government of the People's Republic of Bangladesh (GOB) towards the cost of the Rangpur Division Agriculture and Rural Development Project to be implemented in 38 upazillas and one Metro Agriculture Office under the district of Rangpur, Gaibandha, Lalmonirhat, Kurigram, Nilphamari, Dinajpur, Thakurgaon and Panchagar under the financial assistance of Islamic Development Bank Group (IsDBG) and it intends to apply part of the proceeds of these funds to payments under the contract for the provision of Consultancy services for the project by a national Consulting Firm. The Experience, Resources and Delivery Capacity required are in the discipline of detailed design of irrigation sub-projects, implementation of project activities including procurement, supervision of civil works, quality control, contract management, monitoring etc in order to achieve the project objectives. We published General Procurement Notice (GPN) for the project in the Dainik Sangbad on 31st January 2019.

The specific Terms of Reference of Consultants (Design and Supervision) are as follows.

- a. To prepare specific Engineering drawing / design for irrigation subprojects and supervision of all civil works under the Project.
- b. To assist, review and checking of the detailed engineering estimates, prepare BOQ and bidding document of all physical infrastructure works under the Project.
- c. To certify contractor/supplier/consultant's bill and reimbursement claims, Certify variation order and claims for extension of time or any change in accordance with the contract.

The Project Director, Rangpur Division Agriculture and Rural Development Project, Department of Local Government Engineering Department now invites eligible Applicant to indicate their interest in providing the services. Interested consultants are invited to provide following information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar operating conditions, availability of appropriate skills among staff, etc) in the following order.

- a) Details of organization and key staff with their skill and designation.
- b) List of similar assignments carried out within the past 10 years with their cost.
- c) Present assignment of similar nature and any other information that may show the consultant ability to carryout the assignment satisfactory.
- d) List of references (Clients) with their addresses.
- e) Commercial License renewed up to current year, Vat registration Certificate and income tax clearance certificate up to June/2018.
- f) Any other qualifying information to evaluate the suitability of the Consultants.

Consultants may express interest in the form of Association, validated by an agreement among members of the association (i.e. a joint - venture) to enhance their qualification.

A Consultant will be selected through a short list of qualified national Consultants using with the procedure set out in the guidelines for the use of Consultants under Islamic Development Bank Financing (current edition) and Public Procurement regulation 2008 and Public Procurement Procedures issued by the GOB. It is expected that the services will be commenced on August 2019 and will be completed by June 2023.
